Scope and utilisation

The scope of the Stadium Regulations of Rheinpark Stadium is indicated in a separate site map. The site map is a separate integral part of the Stadium Regulations. The Stadium Regulations are applicable always at Rheinpark Stadium within the indicated sections of the site map.

Approved individuals

Only persons with a valid ticket or a valid pass are entitled to enter Rheinpark Stadium. Stadium visitors acknowledge that by purchasing the ticket, or being handed a pass, they are entering into a reciprocal agreement. If a stadium visitor or a person with a pass breaches this agreement, then he or she shall be expelled from the stadium. In this event, he or she shall not be entitled to reimbursement of the entrance fee. Persons who have been expelled from the stadium, or who are under the influence of alcohol and/or drugs, may not enter Rheinpark Stadium.

Entrance checks

When entering Rheinpark Stadium to attend an event, each visitor shall be obliged to present his or her ticket or pass to the stadium control and security personnel and/or the police, and to submit this to inspection. If this is refused, the control and security personnel shall be entitled to refuse entry to the Stadium, or may eject the respective individual from the Stadium.

Visitors to Rheinpark Stadium must subject themselves to the defined entrance procedure of the control and security personnel.

Behaviour in Rheinpark Stadium

Visitors must comply with instructions issued by the control and security personnel, by the police and/or by the stadium announcer.

Rheinpark Stadium is equipped only with seating, except for events where audiences are permitted on the pitch (concerts etc.). Visitors may occupy only the seating that has been allocated to them. Only the specified entrances and exits may be used to access the Stadium.

Visitors may be allocated seating other than that indicated on the ticket for reasons of security to avert dangers and for other reasons. In this event, visitors shall be obliged to comply with the instructions issued by the control and security personnel and/or the police.

All entrances and exits (stairs), rescue routes and emergency exits must be kept comprehensively unobstructed always.

Prohibitions

Visitors to Rheinpark Stadium may not take animals or the following items and projectiles into the Stadium:

- fireworks (Bengal torches, firecrackers, petards, rockets, etc.),
- cans, glass and PET bottles, Tetra packs,
- WC paper rolls,
- weapons or weapon-like items of all kinds (firearms, knives, knuckle-dusters, baseball clubs, etc.),
- laser pointers,
- megaphones (except with prior consent),
- video cameras and professional photographic equipment,
- drones,
- gas spray cans, pepper spray, corrosive or colouring substances, canisters containing harmful gases (except for conventional lighters)
- suitcases, sport bags, rucksacks, large bags (handbags with dimensions of no more than 25x25x25cm are permitted)

- umbrellas, helmets and other bulky items

Visitors to Rheinpark Stadium may not:

- climb up or over structures and facilities that are not intended for general use, in particular façades, fencing, walls, pitch enclosures, barriers, camera platforms etc.,
- invade the pitch,
- write on, paint on, apply stickers to or destroy building structures, equipment or paths,
- enter areas that are not public areas,
- wear masks,
- relieve themselves outside the toilets,
- carry racist, xenophobic or other radical propaganda material.

Flags

Flags with a hollow plastic pole up to 150 cm in length are permitted. Larger flags require approval. The approval must be obtained from the event organiser.

Not permitted are dual-purpose holders, flagpoles made of wood or metal, large-format slogans and propaganda banners as well as substantial quantities of paper.

Expulsion from the Stadium

Persons shall in every case be expelled from Rheinpark Stadium who:

- allow themselves to be carried away by racist gestures or language,
- consume drugs,
- throw objects,
- take part in quarrels, exhibit aggressive behaviour or insult and/or injure other persons,
- behave uncourteously towards players, referees, functionaries or control and security personnel,
- fail wilfully or through gross negligence to comply with instructions issued by the control and security personnel, by the police and by the stadium announcer.

Contraventions

A civil lawsuit will be filed before the Princely Court of Justice in Vaduz, Liechtenstein, against persons who contravene these Regulations.

They shall be sued for compensation, within the framework of the statutory provisions, if their actions have caused damage. In addition, a fine and/or administrative charge shall be imposed upon all offenders.

It is essentially the case that criminal offences and misdemeanours shall be prosecuted in every case.

Final provision

By acquiring an entrance ticket and/or pass, visitors recognise that the Stadium Regulations and the ticketing GTCs of the Liechtenstein Football Association are binding.

Video recording

For the security of everyone, video recordings shall be made inside and outside Rheinpark Stadium.
